The 3rd Multi-Jurisdictional Hazard Mitigation Planning meeting is set for December 10, 2004 at the Gila Community College in Payson. This meeting is scheduled from 9 am – 1 pm. See address and map at the end of this document.

During the 1st and 2nd meetings, the planning members made progress by identifying the most likely hazardous events to occur in Gila County. Those hazards were then given a CPRI (Calculated Priority Rating Index), which revealed the top five (5) most likely hazards by priority:

1. Flooding
2. Wildfire
3. Thunderstorms
4. Transportation Accident
5. Hazardous Materials Incident

For this 3rd meeting our goals are:

- To have as much Historical Data in place as possible in order to support the top 5 hazards (this list may change depending on the kind and amount of data submitted). Other hazards will be included in the final Hazard Mitigation Plan as well, so all historical data will be considered. We are asking that you look back up to 20 years, if possible. If you need the Historical Hazard Worksheet or the CPRI forms, please contact me as soon as possible and I will forward them in the format you request.
- Review Asset Inventory worksheet data
- Review Capability Assessment worksheet data

Both the Asset Inventory and Capability Assessment worksheets are attached to this document. If you need additional copies please contact me as soon as possible and I will forward them in the format you request. Also, I have copies of all the handouts that were provided in the first 2 meetings, should you need any of those.
