**RULES:** The above tenant agrees to abide by the rules below and the attached statement of the Rules and Policy.

1. This is an RV Park for temporary use only. Reservation limit is four (4) weeks at a time. No group activities or assemblies will be held in the RV Park.
2. Children are welcome at our RV Park. We ask that you please be responsible for your children and ensure that they are under supervision at all times. They are to be courteous of other tenants and their property.
3. There is a quiet time between the hours of 10:00 p.m. and 6:00 a.m. There should be NO generators, loud music or excessive noise that can be heard from a distance of 20 feet. Offensive parties may be cited and /or evicted.
4. Park your vehicle directly in front of your RV. If your vehicle occupies a needed RV space you may be charged. There are not to be more than two vehicles per RV.
5. Use of Park water to wash vehicles and watercraft is prohibited.
6. There are no laundry facilities. Do not hang clothing around the RV.
7. Gila County reserves the right to terminate this agreement at the discretion of the Fairgrounds Management.
8. For Assistance Monday – Friday 7:00 am to 4:00 pm please call the Facilities office at 928-402-4368. In the event that you need after hours assistance, please call the Gila County Sheriff’s Office Dispatch at 928-402-1872. They will contact our on-call personnel.
9. **Check Out Time is 12:00 NOON.**

*If you are boarding horses you will need a key to get through the gates. Please schedule the pick-up and drop off of the key with Kelly Jones (928) 402-4368.*

**I have read the Gila County Fairgrounds Rules and Policies and agree that my group will observe these Rules and Policies for the duration of our stay.
