**METHOD OF CALCULATING BUILDING PERMIT FEES

**PLAN REVIEW FEES:**

A plan review fee shall be paid at the time of submitting the submittal documents for plan review. Said plan review fee shall be 65 percent of the building permit fee as shown in Table 1-A. The plan review fees specified in this section are separate fees in addition to the permit fees.

## ELECTRICAL PERMIT FEES

### Permit Issuance

1. For issuing each permit -----\$25.00

### System Fee Schedule *(Note: The following do not include permit-issuing fee.)*

#### 1. New Residential Buildings

The following fees shall include all wiring and electrical equipment in or on each building, or other electrical equipment on the same premises constructed at the same time. For new multifamily residential buildings (apartments and condominiums) having three or more living units not including the area of garages, carports and other--- noncommercial automobile storage areas constructed at the same time, per square foot -----0.50

For new single-and two-family residential buildings not including the area of garages, carports and other minor accessory buildings constructed at the same time, per square foot-----0.055

For other types of residential occupancies and alterations, additions and modifications to existing residential buildings, use the UNIT FEE SCHEDULE.

#### 2. Private Swimming Pools

For new private, residential, in-ground, swimming pools for single family and multifamily occupancies including a complete system of necessary branch circuit wiring, bonding, grounding, underwater lighting, water pumping and other similar electrical equipment directly related to the operation of a swimming pool, each----- 30.00

For other types of swimming pools, therapeutic whirlpools, spas and alterations to existing swimming pools, use the UNIT FEE SCHEDULE.

### Unit Fee Schedule *(Note: The following do not include permit issuing fee.)*

#### 1. Receptacle, Switch, Lighting Outlets and Lighting Fixtures

For receptacle, switch, lighting or other outlets, lighting fixtures, sockets or other lamp- holding devices at which current is used or controlled, except services, feeders and meters.

First 20, each ----- 1.00

Additional outlets, each ----- .50

*(Note: For multioutlet assemblies, each 5 feet or fraction thereof may be considered as one outlet)*

#### 2. Signs, Outline Lighting and Marquees

For signs, outline lighting systems or marquees supplied from one branch circuit, each -----

25.00 For additional branch circuits within the same sign, outline lighting system or marquee, each ----- 5.00

#### 3. Services

For services of 600 volts or less and not over 200 amperes in rating, each -----25.00

For services over 600 volts or less and over 200 amperes to 1000 amperes in rating each-----50.00

For services over 600 volts or over 1000 amperes in rating, each -----100.00

1. Inspections outside of normal business hours -----50.00 per hour<sup>1</sup>

2. Reinspection fee -----50.00 per hour<sup>1</sup>

3. Inspection for which no fee is specifically indicated -----50.00 per hour<sup>1</sup>

**Permit Issuance**

1. For issuing each permit -----\$25.00

**Unit Fee Schedule** (in addition to item 1)

- 1. For each plumbing fixture on one trap or a set of fixtures on one trap (including water, drainage piping and backflow protection therefore)-----\$10.00
- 2. For each water heater and/or vent-----10.00
- 3. For each gas-piping system of one to five outlets -----5.00
- 4. For each additional gas piping system outlet, per outlet -----1.00
- 5. For each installation, alteration or repair of water piping and/or water treating equipment, each -----10.00
- 6. For each repair or alteration of drainage or vent piping, each fixture -----10.00
- 7. For atmospheric-type vacuum breakers:
  - 1 to 5 -----5.00
  - over 5, each -----1.00
- 8. For each backflow prevention device other than atmospheric type vacuum breakers:
  - 2 inch diameter and smaller -----10.00
  - over 2 inch diameter -----18.00
- 9. For each gray water system -----50.00

## MECHANICAL PERMIT FEES

### Permit Issuance

1. For the issuance of each permit -----\$25.00

### Unit Fee Schedule

1. For the installation or relocation of each forced-air or gravity-type furnace or burner, including ducts and vents attached to such appliance, up to and including 100,00 Btu/h -----\$12.00
2. For the installation or relocation of each forced-air gravity-type furnace or burner, including ducts and vents attached to such appliance over 100,000 Btu/h-----15.00
3. For the installation or relocation of each suspended heater, recessed wall heater or floor-mounted unit heater -----12.00
4. For the installation or relocation of each boiler or compressor to and including three horsepower, or each absorption system to and including 100,000 Btu/h-----10.00
5. For the installation or relocation of each boiler or compressor over three horsepower to and including 15 horsepower, or each absorption system over 100,000 Btu/h and including 500,000 Btu/h -----18.00
6. For the installation or relocation of each boiler or compressor over 15 horsepower to and including 30 horsepower, or each absorption system over 500,000 Btu/h to and including 1,000,000 Btu/h -----25.00
7. For the installation or relocation of each boiler or compressor over 30 horsepower to and including 50 horsepower, or for each absorption system over 1,000,000 Btu/h to and including 1,750,000 Btu/h -----35.00
8. For the installation or relocation of each boiler or refrigeration compressor over 50 horsepower, or each absorption system over 1,750,000 Btu/h -----60.00
9. For each air-handling unit to and including 10,000 cubic feet per minute, including ducts attached thereto -----10.00  
 Note: This fee shall not apply to an air-handling unit which is a portion of a factory-assembled appliance, cooling unit, evaporative cooler or absorption unit for which a permit is required elsewhere in this code.
10. For each air-handling unit over 10,000 cfm -----15.00
11. For each evaporative cooler including duct work other than portable type -----10.00
12. For each ventilation fan or system which is not a portion of any heating or air-conditioning system authorized by a permit -----10.00
13. For the installation of each hood which is served by mechanical exhaust, including the ducts for such hood -----10.00
14. For the installation or relocation of each domestic-type incinerator -----15.00
15. For the installation or relocation of each commercial or industrial-type incinerator-----45.00

(includes plan review and inspections for pool, plumbing, electric, mechanical & barrier requirements.)

Private .....	\$350.00 min.*
Public .....	500.00 min.*

\*May be calculated based on valuation if minimum fee not sufficient for service provided.

### For each pre-fabricated pool, spa or hot tub

Base fee on permits required for project.
