

Please Note: *Generally, the CSA Board of Directors meetings would begin at 10:00 a.m. with lunch provided at noon and held at CSA. An exception might be when the board meeting is held in conjunction with an AACo conference offsite or when held in conjunction with the CSA Legislative Summit.*

The County Managers/Administrators meetings generally begin at 10:00 a.m. and held at CSA. An exception would be when the meeting is held offsite at a location around the state or when held prior to a Legislative Policy Committee meeting.

Generally, the CSA Board of Directors meetings are held the third Thursday of the month. An exception might be when the board meeting is held in conjunction with an AACo conference or when held in conjunction with the CSA Legislative Summit.

Generally, the County Managers / Administrators meetings are held the second Friday of the month (or the Friday before the CSA board meeting). An exception might be when the CSA board meeting date is changed.
