The Board may vote to go into executive session pursuant to A.R.S. 38-431.03(A)(3)(4) in order to seek legal advice from its counsel and to instruct its counsel regarding settlement discussions.

Upon motion by Vice-Chairman Martin, seconded by Supervisor Pastor, the Board moved into executive session at 2:33 p.m.


Chairman Dawson reconvened the meeting into regular session at 3:00 p.m.


There being no further business to come before the Board of Supervisors, Chairman Dawson adjourned the meeting at 3:01 p.m.
