



**RESOLUTION NO. 13-11-01**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF GILA COUNTY, ARIZONA, AUTHORIZING AN INCREASE IN THE FEES CHARGED BY GILA COUNTY RABIES CONTROL EFFECTIVE DECEMBER 1, 2013.**

**WHEREAS**, pursuant to Arizona Revised Statutes Section 11-251.08 – *County fee for service authority; alternate fee schedule; fee limits; adoption procedures*, the Board of Supervisors is authorized to adopt fee schedules; and

**WHEREAS**, the Gila County Board of Supervisors has not increased fees charged by its Rabies Control Department for over sixteen (16) years; and

**WHEREAS**, due to increased fuel, labor, building, and veterinary medical costs, it is necessary to increase the fees currently being charged by Gila County Rabies Control; and

**WHEREAS**, a comparison has been completed of the current fee structure against six other Arizona counties and animal control agencies (Pinal, Pima, Maricopa, Greenlee and Yavapai Counties; and Apache Junction, Payson, and Safford Animal Control); and


**WHEREAS**, it was determined that Gila County was far below the average of those agencies.

**NOW, THEREFORE, BE IT RESOLVED** that the Gila County Board of Supervisors does hereby adopt a revised Rabies Control Fee Schedule, of which said fees are outlined in Exhibit "A" attached hereto and by this reference made a part hereof to this resolution, which will go into effect on December 1, 2013.
