A RESOLUTION OF THE BOARD OF SUPERVISORS OF GILA COUNTY, ARIZONA, APPROVING A PRECINCT CONSOLIDATION AND MAIL BALLOT PRECINCT PLAN FOR THE MAY 18, 2010, SPECIAL TAX ELECTION.

WHEREAS, Governor Jan Brewer has issued a proclamation establishing that a Special Tax Election will be held on the 18th day of May 2010; and

WHEREAS, the Governor has declared this shall be a consolidated precinct election.


NOW THEREFORE, BE IT RESOLVED that we, the Gila County Board of Supervisors, approve of the locations shown on Attachment A as designated polling places for the May 18, 2010 Special Tax Election; and

BE IT FURTHER RESOLVED that as the precincts of Christmas and Whispering Pines contain fewer than 200 active registered voters, the May 18, 2010, Special Tax Election shall be conducted by a mail ballot, with designated mail ballot replacement sites available on election day.




